He won numerous gold and silver medals in the Jamaica Music Festival and was chosen as the Most Outstanding Male Singer in Jamaica for two consecutive years. He received extensive vocal coaching and training from outstanding musicians, including Jamaican famous opera singer Joyce Britton. Barrington Brennen has performed in The Bahamas, Jamaica, Martinique, France, and the United States. He also plays the piano and organ. He was the church organist at the Grant's Town Church, Nassau, from the age of twelve until he went to college at age eighteen.
